Detachment Awards

The committee will validate the information provided and select the most qualified potential recipients, and then forward their recommendations to the Detachment Commandant and Board of Trustees for final consideration. Following discussions of the potential recipients it will be the Commandant's final decision as to the awardee.

The awards that we traditionally present include:

The Marine of the Year Award, this award is voted on solely by past Detachment recipients of the Marine of the Year Award. It is our practice that the most recent recipient of the Marine of the Year Award will act as the Chairperson of this committee.

The Associate Member of the Year, this award is given to the Associate member who is active-

The Certificate of Appreciation award can be given by the Detachment in acknowledgement of any act or action by an individual, company or organization that either benefitted the Detachment or promoted the Detachment for the good of the League.

The Commandant's Award is a personal recognition certificate that is given at the discretion of the Detachment Commandant.
