A nomination letter is included. Any detachment member can nominate someone for any of the awards except for Marine of the Year and the Commandant's Award. All submissions need to be given to the awards committee, headed up by myself, so we can validate the information provided and forward the recommendations to the Commandant and Board for final selection. The awards that we traditionally present include:

Marine of the Year. This award is voted on solely by past Detachment MOTY awardees. Recipients should clearly exceed in all they do, work in concert with the Detachment, and are committed to our success. It is our practice that the most recent recipient of the MOTY Award acts as the Chairperson of this committee.

Associate Member of the Year. This award is given to the Associate member who is actively involved with the Detachment and does the most to promote the Detachment and its programs as well as most exemplifying the spirit of the Marine Corps League.

Distinguished Citizen. This award is presented for distinguished service above and beyond what would normally be expected to either the Marine Corps League or the community. Our Detachment places a heavier weight on the service to our community as a whole, as opposed to the Marine Corps League; we believe the Distinguished Service Award is more fitting for exemplary service to the League. Commandant's Award. This is a personal recognition certificate that is given at the discretion of the Detachment Commandant.
