Zaina Nait Omar, a Clemson University History student discovered some information of a Seneca resident and former Clemson University student that was in the Battle for Iwo Jima. In her research of Corporal Foster Doyle Mitchell, USMC she discovered that he has no living decedents.

Zaina wanted everyone to know about Foster Doyle Mitchell's service to this country in the Battle of Iwo Jima, so she contacted Jeff Duncan, Congressman 3rd District, SC and requested that a U.S. Flag be flown over the U.S. Capital in honor of Corporal Foster Doyle Mitchell, USMC. Congressman Duncan did that and forwarded the flag to Zaina Nait Omar.

Ms. Omar thought the flag should be presented to and maintained by a Marine Corps organization for the public to see. Ms. Omar presented the flag to the Marine Corps League, Detachment 1131, Seneca, SC at its February 15, 2022 business meeting.



Foster Doyle Mitchell graduated from Seneca High School as a member of the class of 1940. He attended Clemson College for two years, and his mother, Susan Selma, passed away on January 14, 1941, leaving Foster without his parents at around twenty years old. He left Clemson as a Sophomore to enlist in the Marine Corps, and was assigned to the 25th Regiment of the 4 Marine Division. He was engaged in the Battle for Iwo Jima. He landed on the Northern Sector on the Yellow and Blue beaches under the command of Col. John R. Lanigan, USMC.
